Transitioning from paper can seem overwhelming, but with the right help, the company should be able to make a painless transition into electronic quality management.

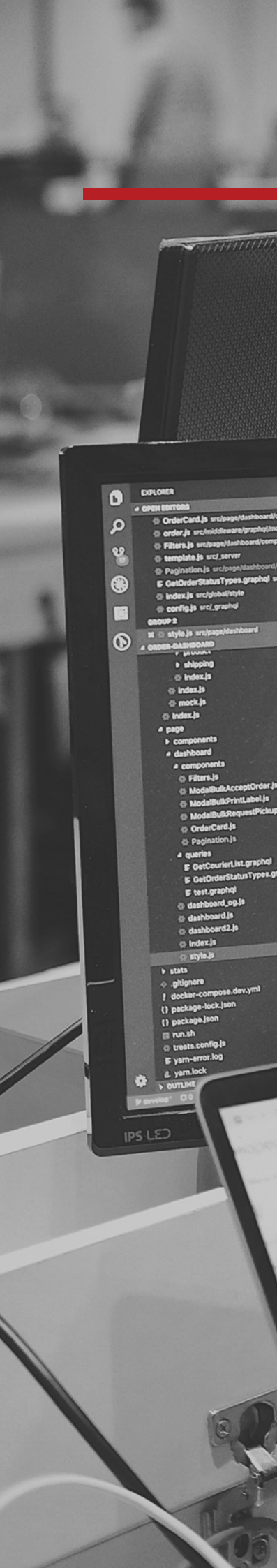
